PUBLIC CALL PROPEX N° 004/2020 REGISTRATIONS FOR THE 32TH EDITION OF THE FITUB

THE FOUNDATION UNIVERSIDADE REGIONAL DE BLUMENAU, through the *Pró-Reitoria de Pesquisa, Pós-Graduação, Extensão e Cultura*, makes a public call for the opening of registrations for the 32th edition of the International Theater Festival of the city of Blumenau, promoted by the Universidad Regional de Blumenau (FURB) that will be held from the 09th to the 16th of July 2019 in Blumenau, Santa Catarina, and Brazil.

REGISTRATIONS

Art.1° – Registrations for the 32th Theater Festival of the city of Blumenau will be available for Theater Companies associated with Higher Education Institutions (teaching, investigation and its extensions), Technical schools of High School level accredited by a competent Education Institution and the Theater Free Schools.

Art.2°- The Companies must be recognized and accredited by the Direction of their Institution, specifically for their participation in the 32th Theater Festival of the city of Blumenau, showing that the performance presented is the fruit of the work undertaken within their Institution, guided by a **professor or a professional** in this field.

Art.3°- Every selected Company is allowed to participate with: a Director, two Technicians and the Cast. The Organization of the Festival will assume the responsibility for the housing, breakfast and meal vouchers expenses up to fifteen participants.

Art.4°- The plays presented may be unreleased, already published or already presented in other Festivals.

Art.5°- Registrations can be done via the site: www.furb.br/fitub until April 12th, 2020.

Art.6 ° - In order to be registered **on-line**, the Company Manager must:

I - Fill in the registration form at the following link: <u>www.furb.br/fitub</u>, stating your agreement with the rules of the 32th FITUB.

II - Provide digital links which lead to:

- a) A faithful digital recording of the performance, including the staging and the cast, without editing. Camera and Zoom movements and changes are allowed. In the case that the performance hasn't been released yet, the Company is expected to send a recording of a general rehearsal.
- b) Digital pictures of the performance (300 pixels minimum).
- c) Schedule, brochure, etc, (in digital form) of the performance.
- d) Director's, teacher's and consultant's CVs (if relevant).

e) Mise en scene, presentation, creative process, synopsis, technical files, stage maps, lighting and sound).

f) A complete copy of the text presented, joined by an authorization from the author or his legal representative for the production and a full copy of the original text (if the play is an adaptation).

g) Document/declaration of the Direction of the Teaching Institute, according to the 2nd article included in the official rules.

Art.7°- To omit any of the items demanded in this form could lead to a refusal of the registration and the Jury's decisions shall be sovereign.

CONCERNING THE JURY

Art.8°- The Jury in charge of selecting the performances from the 32th International University Theater Festival of Blumenau will be composed of 03 (three) Scenic Arts professionals, one of them being a representative from the University.

Art.9°- The Jury of the Festival, in charge of the selection criteria of the performances presented in the 32th International University Theater Festival of Blumenau will have an autonomy status to judge the fulfillment of the rules of the Festival.

Art.10° –The information about the performances selected will be available from April 20th, 2020. at <u>www.furb.br/fitub</u>.

COMPANIES OBLIGATIONS

Art.11°- The Company must be available to perform at **any time during the Festival**, on a date to be determined by the Board – otherwise the Company will be disqualified and another Company will substitute them. The information will be given in due time, according to the classification order of the selected Companies.

Art.12 • - In addition to their main performance, the Companies selected to participate in the International University Theater Festival of Blumenau will be responsible for giving **two additional performances** in a place to be determined by the Organization of the Festival.

Art.13°- The Company must have its own means of transportation, both for the Cast and the Stage, in order to arrive at the performance location and to return.

Art.14° - The selected Companies must report to the Organization board at least 12 hours before the beginning of their performances.

Art.15° - As scheduled in the program of the Festival, the Director and his Company must be present at the Analysis of the Performance, held by professionals invited by the Organization of the Festival in a public session.

Art.16 ° - Performances must be strictly in conformity with the information published in the program.

(The Organization will open the doors of the hall **15 minutes** before the beginning of the performances, except for public and known reasons that are accepted by the Organization of the Festival).

Art.17°- The Companies are responsible for supplying the scenery and the technical equipment required for their performance, except for the basic technical structure (lighting and sound), which shall be provided by the Organization of the Festival.

Art.18°- A Company which for any reason cancels its performance, shall be automatically disqualified from participating in the upcoming editions of the Festival.

CONCERNING THE OBLIGATIONS OF THE ORGANIZATION OF THE FESTIVAL

Art.19° - Each selected group will be entitled to a fee R\$ 3.140,00 (three thousand one hundred and forty reais), to be paid to the group leader until 10 (ten) days after the end of the Festival,), or to the individual, and in the latter case, on the amount paid, will deduct the appropriate taxes.

Art.20° - The Organization will provide housing and breakfast (up to 15 participants) for all the selected Companies, except for the ones from Blumenau.

Art.21° - The Organization will provide a food voucher, worth R\$ 10,00 (ten reais) for each meal (lunch and dinner) up to 15 participants of each Company.

Art.22° - The Organization shall provide (up to) 60 light reflectors and an electric system (220 volts) at no extra cost for the Company.

Art.23 °- The Organization will provide a participation certificate.

GENERAL RULES

Art.24°- The organization of the Fitub does not assume any responsibility for the housing and food expenses prior to the beginning of the Festival or after its ending.

Art.25°- The Commission in charge of the analysis of the performances is entitled to deliver an honorable mention to the participating Companies as well as to other aspects of the performance, according to her criteria established by the Commission itself.

Art.26°- The Registration demand for the 32th International University Theater Festival of Blumenau will engage the participating Companies, authors and co-authors to authorize the wide and unrestricted publication of the images and sound of the performance, a clause that includes the whole cast and crew of the Company.

Art.27°– By signing this registration form, the participating Companies' members certify to be completely and unrestrictedly in agreement with the rules written in this document. The non-fulfillment of these obligations could lead to the loss of the right of payment as stipulated in the article 19.

Art.28°- The Organization of the 32th International University Theater of Blumenau will rule in the case of specific situations that were not considered in this document.

Art. 29° -The organization of the 32st International Theater Festival of Blumenau establishes the following schedule:

a) Disclosure of the announcements and opening of registrations: 10/March/2020 to 12/April/2020;

b) Disclosure of Result: 27/April /2020

c) Festival performance: 09 to 16/July/2020.
